Regulations of the International Conference entitled
"Wood - the material of the 21st century. Woodworking and forestry for material and construction needs in an innovative economy"

June 5-6, 2025

1. General Provisions

- 1.1. These regulations apply to the Conference entitled "Wood the material of the 21st century. Woodworking and forestry for material and construction needs in an innovative economy" organized on June 5-6, 2025 in Warsaw, hereinafter referred to as the Conference.
- 1.2. The conference is organized on the SGGW campus in Warsaw, in building no. 34. The conference is organized by the Institute of Wood Sciences and Furniture, SGGW in Warsaw.
- 1.3. The conference is international and is addressed to all scientific communities conducting scientific research related to forestry and woodworking. It is also addressed to companies from the forestry and wood management sector.
- 1.4. The Conference Participants are Active Participants, i.e. those presenting and delivering a paper or poster, who will send the Application Form and the topic of the paper or poster within the specified time, as well as Passive Participants, i.e. all other participants who will be listeners to the papers, also registered through the Application Form.
- 1.5. Each active Conference Participant will receive a certificate of participation in the Conference. Certificates will be in the printed form.
- 1.6. The Organizers reserve the right to cancel the Conference in case of an insufficient number of Participants or for other reasons beyond the control of the Organizers.

2. Rules of Participation and Withdrawal of Participation

- 2.1 Participants apply for the Conference by sending the Application Form via the Forms application, containing name and surname, affiliation of the scientific unit or company, topic of the paper or poster, contact details, and invoice details. The Organizers will confirm acceptance of the application by sending a return e-mail within three working days.
- 2.2 The Conference Organizer provides hall for 200 people, equipped with a computer with Internet access, a multimedia projector, a sound system, a microphone, and an induction loop.
- 2.3 The paper or poster should be prepared and presented in English. However, Polish is also acceptable.
- 2.4 In the case of co-authorship of a paper or poster by multiple authors, the paper during the Conference should be presented as an oral presentation by only one.
- 2.5 The Participant bears full responsibility for all materials and information presented by him during the Conference. The Participant is obliged to ensure that all statements and presentations given by him/her during the Conference do not violate legal regulations or the rights or personal rights of third parties.
- 2.6 One Participant can submit maximum two topics (paper or poster).
- 2.7 The presentation of the paper should last a maximum of 20 minutes and be supported by a multimedia presentation prepared in PowerPoint format.
- 2.8 The poster should be in A1 format and contain the following data: title of the poster, name of the author(s) and affiliations placed under the title, a summary, a clearly defined research objective, a description of the research methods used, a presentation of the leading research findings and conclusions. Clear graphics that support the content of the poster are recommended.
- 2.9 The conference fee is PLN 1,000 for Participants from Poland and EUR 250 for Participants from abroad.

3. Final Provisions

- 3.1 The provisions of these regulations apply to all Participants. Registering as a Conference Participant is tantamount to accepting the above rules.
- 3.2 In matters not regulated by these Regulations, the provisions of the Civil Code shall apply.
- 3.3 These Regulations shall enter into force on the day of their posting on the Institute of Wood Sciences and Furniture website at the Warsaw University of Life Sciences.
- 3.4 The Organizer has the right to change the provisions of the Regulations. Changes shall enter into force within 7 days of their posting on the Institute of Wood Sciences and Furniture website at the Warsaw University of Life Sciences.
